This offer is extended to Bathurst Harness Racing Club under the following conditions:

1. The offer closes at 6:00pm on Wednesday, 30 September 2026.
2. The offer applies to the service fee only and excludes all associated costs, including (but not limited to) agistment, insemination, veterinary expenses, and shipping.
3. The successful tenderer will be the highest bidder on or above the nominated reserve price.
4. The minimum reserve prices are predetermined by the BHRC and/or the relevant studs.
5. In the event of multiple tenders of the same value for the same service, each identical offer will be entered into a random draw conducted by the BHRC Committee, with the winner selected accordingly.
6. The successful tenderer will be notified within three (3) working days of the tender closing via both phone and email. Payment in full must be made to the Bathurst Harness Racing Club by Wednesday, 7 October 2026. Failure to make payment by this date will result in the service being offered to the next highest bidder.
7. The service fee is valid for the 2026 breeding season only, unless otherwise agreed with the stud.
8. For services other than those provided by Woodlands Stud, the HRA Stallion Tax, where applicable, will be invoiced directly by the stud upon a positive 42 day pregnancy test, payable in addition to the tendered service fee amount.
9. All proceeds will be directed to the Bathurst Harness Racing Club on behalf of the contributing studs.
10. The Bathurst Harness Racing Club accepts no liability for the outcome of any service, or for any arrangements made between the successful tenderer and the stud. Any missed services are the responsibility of the tenderer to follow up directly with the stud involved.
